Applications

In heavily soiled areas it may be necessary to work the product in with a brush. Once this has been done, the product should be left for a minimum of 2 minutes. Engine Cleaner then washes off easily with water carrying the contamination away in suspension - leaving a perfectly clean and grease free surface.

Can be used with steam cleaning machines.

Instructions

1. Spray liberally in engine bay using Kent Trigger Bottle (BT1), especially over heavily soiled areas.
2. Alternatively apply with a brush
3. Allow to penetrate grease for 2-5 minutes
4. Wash area completely with water until clean
5. Repeat on heavily soiled areas if necessary.

N.B. Avoid applying product directly on to electrical components and hot surfaces.
