#### Instructions for use

**1.** Clean the surface to be treated with Kent Acrysol until all excess grease or wax has been removed. Allow to dry.

**2.** If the surface to be treated is corroded, clean up with a wire-brush or sand-blast.

Clean again with Kent Acrysol.

Apply a thin layer of Kent Galvapro, as needed. In order to speed up drying time, use a hot air gun  $(max.150^{\circ}C)$ 

**3.** Apply Kent Wheel Spray evenly in a thin layer on the still warm (approx.20°C) wheel rims or covers. **4.** If necessary apply a second coat after approx.3-5 minutes
