- Increase bond strength of MS Polymers to wide range of substrates - ceramic coated or plain glass, plain aluminium, steel
- Fast drying – within 2 minutes - Decrease time required to change windscreen
- Easy to use “wash primer” - cleaner and adhesion promoter in one product – saves time

Applications

MS Prep is designed to increase adhesion of Screenfix and Screenfix 212 when adhering to painted surfaces.

It is only required when the “long” method of screen replacement is used, or if a screen is fitted to a new panel where there is no old adhesive present. (Long method involves removing all adhesive before re-fitting glass as opposed to adhering new adhesive over old adhesive).

Instructions

1. Use with MS-Polymer based sealant / adhesives.
2. With a clean, dry cloth remove any excess dirt from surface.
3. Apply a small quantity of KENT MS Prep to a clean non-synthetic cloth and carefully wipe over area to be sealed/bonded.
4. When used for windscreen replacement, apply to metal/painted surface.
5. Allow to dry before applying sealant/ adhesive onto surface.
6. Once opened use within 1 month, protect from contamination and evaporation. Ensure can is tightly sealed with plastic cap after use and store in a well ventilated place.
