Application

KENT A/C UV Dye Cleaner is designed to remove fluorescent dye residue from the leak area, once the leak has been located and satisfactory repairs have been completed. When the residue has been removed the system can be re-tested to ensure that the leak has been rectified.

Instructions

1. Spray directly onto surface to be cleaned.
2. Allow it to penetrate briefly.
3. Wipe with a damp cloth. Do not allow surface to dry.
4. For fabrics and carpets test first in an inconspicuous area for color testing.
