Application

Instructions

- 1. Turn off power to equipment being cleaned.
- 2. Fit the extension tube provided to reach more inaccessible areas.
- 3. Keep the can in an upright position when spraying to avoid discharging liquefied propellant (freezing effect).
- 4. Invert the can when spraying to activate freezing effect.
- 5. Spray area and allow KENT Blow Jet to completely evaporate before restoring power to equipment.

Attention:

Don't spray on active electronic components and ensure that the propellant has evaporated before starting equipment / device again. Don't spray on body parts.
